This 6 is our recent past. The document will be 7 released digitally today around noon, but I was 8 convinced that this Board was the right place 9 for it to be introduced. 10 We have increased capital investment every 11 year since 2017 in our state, including three 12 consecutive years now of more than twenty 13 billion dollars for the first time in the 14 State's history. We have the lowest 15 unemployment rate in our State's history.  19 But I will tell you, Don, that it has been
 20 a pleasure to work with you for the past eight

 11 know I talk low and it comes from my heart. So
 12 y'all understand me, everything comes from my
 13 heart, but I want to thank you, Chairman, Mr.
 14 Don, and especially the staff and everybody
 15 that sits in this room.
 16 As a freshman legislator coming in here
 17 and had the chance that a chairman gave us,
 18 gave me the opportunity to be her proxy,
 19 because she said that I knew what I was doing
 20 and some people do not believe it, but, and I
 21 had to come in, and when I came in, especially
 22 Senator Hollier, because we had solar and wind
 23 and now I call them capture coming in, and
 24 y'all trusted me because Louisiana was not
 25 ready. We had 125 MISO (sic) site locations,

1 and we wanted to protect landowners and we
 2 wanted to protect the State of Louisiana with
 3 these contracts, because my family has been --
 4 my brother was executive secretary of the
 5 Public Service Commission for 30 years, and
 6 they were dealing with this, and had the
 7 understanding that ITE was job driven, and so,
 8 it has but one job on each site, and it costs a
 9 million dollars just to get an application for
 10 MISO to do -- so they were coming in here with
 11 two men in a truck, big solar companies and
 12 everything were trying to think, and all this
 13 was to help. What we did was save a lot of
 14 landowners, because they were coming in here
 15 and there is no place other than the United
 16 States that understands oil and gas leases,
 17 understands everything that we did, so we put
 18 in, we passed bills, passed them in the thing.
 19 Now we are protected and we are ready for solar
 20 and wind.
 21 Now, I do not know how I can thank y'all
 22 and we can come in here and y'all believe this,
 23 and now we ready, and I want to thank y'all.
 24 This Board -- I have served on a lot of
 25 Boards and this Board really is compassionate,

1 knows what they are doing, and we do not know
 2 what is going to happen in the building out
 3 there. I am hoping I am on Commerce again, but
 4 we do not know. The process is being changed,
 5 so what we do is, we all love Louisiana and we
 6 do what we got to do, but that process over
 7 there in that building, it is hard to change, I
 8 can tell you.
 9 I would like to really talk about just for
 10 a few minutes, and I really want you to listen
 11 to these numbers, and this started with Mike
 12 Foster when we formed the Community and
 13 Technical College. State of Louisiana, these
 14 boards, everything we want to stop our
 15 congregation -- and keep our kids. We want
 16 insurance and crime and all this stuff we are
 17 talking about. But the numbers I am going to
 18 tell you right now is a people problem. Until
 19 we solve this, we cannot be able to move.
 20 The age from 25 to 64, working age,
 21 42 percent of that to a million, eight hundred
 22 and forty thousand eligible people to work.
 23 And I go to work; them who do not want to work,
 24 or they want to live in the welfare system.
 25 What we have to do is, they can earn forty-two

1 thousand five hundred dollars on the system.
 2 Every job that Community Technical College
 3 workforce will guarantee sixty-five thousand
 4 when you start. We have to move these, just a
 5 third of them. If we can get a third into jobs
 6 that these companies and everybody needs, then
 7 we will be successful.

8 So, when you out and you hear of anybody
 9 that is looking for a job, doing everything,
 10 the Community and Technical College system will
 11 train you for free on most of everything with
 12 the Foster comp, everything. Until we change
 13 this people problem, and change just maybe a
 14 third of them from forty-two thousand that we
 15 think nothing to sixty-five thousand taxpayers
 16 there. The taxes that they will pay is going
 17 to put us at a level that we can start.
 18 Eliminating income tax can start eliminating
 19 less taxes.

20 But this is our problem. When you give an
 21 ITE and everything and you did your job, just
 22 remember that we still have this most important
 23 job to do, is to get eight hundred and forty
 24 thousand, some of them back to work in
 25 Louisiana, and then we have all the stuff.

1 I was with a business last week, they are
 2 a thousand short right now. They are going to
 3 hire a thousand people today, train them for
 4 free, and have them ready, and they will start
 5 at sixty-five thousand, and over time they will
 6 go to a hundred thousand.

7 So, this is the problem. I ask for
 8 y'all's help. Remember these figures, eight
 9 hundred and forty thousand that are not in our
 10 work force. Forty-two percent of people that
 11 can work are not in the workforce.

12 I want to thank y'all for giving me the
 13 time, and this is an extremely good Board.
 14 Very compassionate. Every business that came
 15 here got a good look and was really given a
 16 good chance, and if it is possible, I might be
 17 back. If not, thank y'all for letting the
 18 freshman legislator come in here and y'all
 19 trusted me and trusted and we saved a lot of
 20 business and we saved a lot of landowners. So,
 21 we are -- we were not ready. And as of right
 22 now, MISO has shut down solar right now for a
 23 year. They had 340 solar projects in the State
 24 of Louisiana, and you got to pay a million
 25 dollars just to get the permit.

1 So, you know what kind of money that is
 2 coming in. We ready. We made the laws. Now
 3 let's welcome them in. Thank you.

4 MR. JONES: Mr. Nassar.

5 MR. NASSAR: Yes. Before I get started, I
 6 would like to thank Representative St. Blanc in
 7 the work that he has done on the House
 8 Education Committee for Public Schools, and
 9 just to kind of take it back a little bit on
 10 what the representative said, and I know this
 11 goes on throughout the State of Louisiana in

 15 we would not be able to offer what I am getting

 21 industrial coating, industrial insulating,
 22 scaffold building at cost efficient, zero
 23 moneys. Apache, a company that does insulating
 24 and painting, scaffold building, any industry
 25 actually comes in and train our students that

1 is not going to go to college on how to do
 2 those job skills. They buy their tools for
 3 them when they finish the course. They buy
 4 their quick card for them, and they train them.
 5 Get them a job starting at over forty thousand
 6 dollars a year. These kids go work in
 7 industry, some of them end up working for the
 8 refineries or the chemical manufacturers that
 9 they were actually working for the contractor.
 10 Some of them will go back to college and become
 11 engineers.

12 My whole point is, there is a way and
 13 there is a path to doing exactly what
 14 Representative St. Blanc said; we just need to
 15 stay on top of it.

16 But with that being said, Jerry, I would
 17 like to thank you for the way you conducted
 18 meetings. I want to thank you for the
 19 questions you asked. It stops a lot of the
 20 discussion that we need to have because of the
 21 questions you do ask.

22 For the industries, business and industry
 23 that comes before the Board of Commerce &
 24 Industry, I hope you realize that we do take
 25 each individual case and look at it from an
