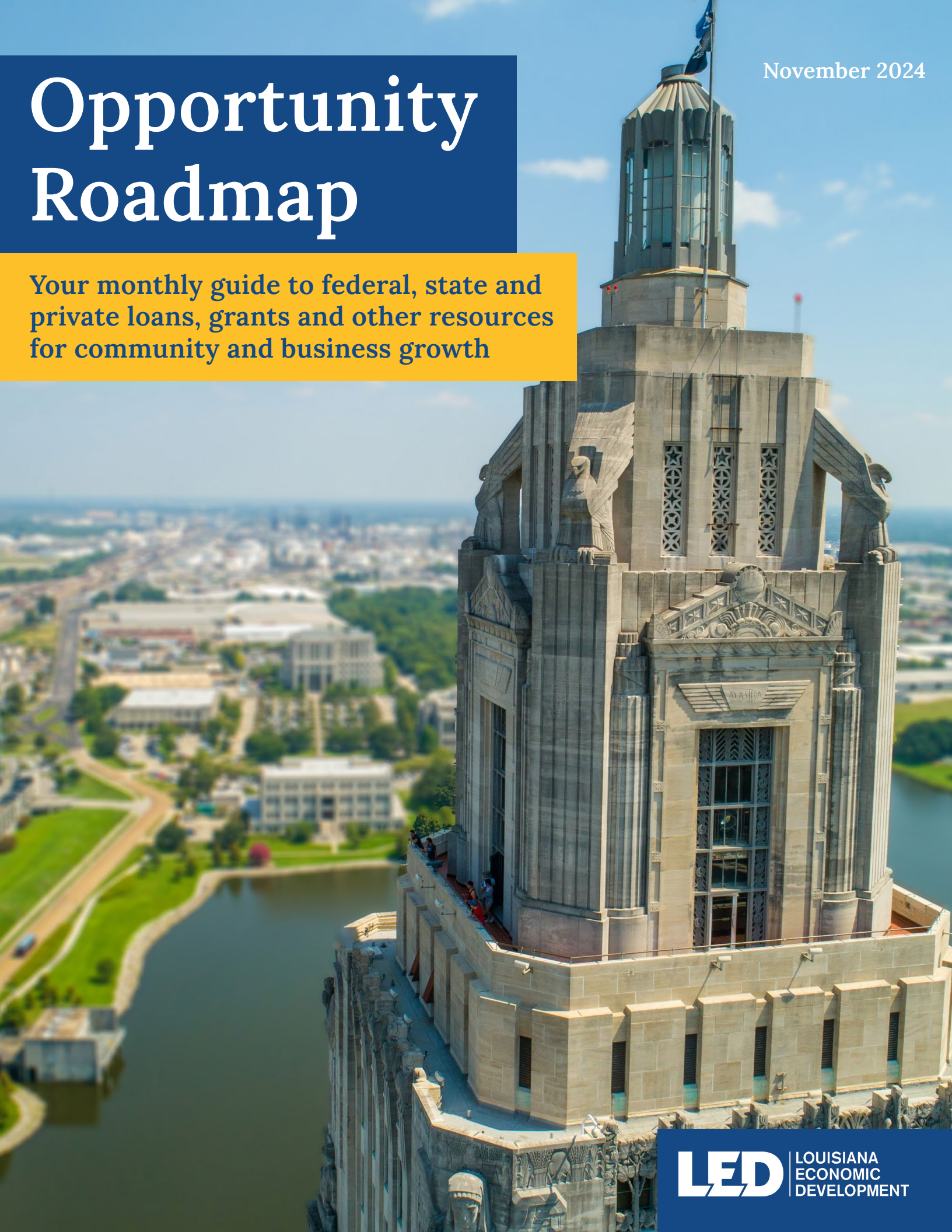

# Loans

## USDA Rural Development

### **BUSINESS & INDUSTRY LOAN GUARANTEES**

For-profit or non-profit businesses, cooperatives, federally-recognized tribes, public bodies, and individuals engaged or proposing to engage in a business are eligible for this loan.

#### **Use of funds:**

- » Business conversion, enlargement, repair, modernization, or development.
- » The purchase and development of land, buildings, and associated infrastructure for commercial or industrial properties
- » The purchase and installation of machinery and equipment, supplies or inventory
- » Debt refinancing when such refinancing improves cash flow and creates jobs
- » Business and industrial acquisitions when the loan will maintain business operations and create or save jobs

**\*Applications accepted on a rolling basis**

**\*Grant award maximum 80%**

### **COMMUNITY FACILITIES DIRECT LOAN AND GRANT PROGRAM**

Rural areas including cities, villages, townships and towns including Federally Recognized Tribal Lands with no more than 20,000 residents are eligible for this program.

#### **Use of funds:**

- » Health Care Facilities
- » Public Facilities
- » Community Support services
- » Public Safety Services
- » Educational Services
- » Utility Services (i.e. telemedicine or distance learning equipment)
- » Local Food Systems
- » For a complete list see Code of Federal Regulations [7 CFR, Part 1942.17\(d\)](#) for loans; [7 CFR, Part 3570.62](#) for grants

**\*Grant award maximum 55%**

### **COMMUNITY FACILITIES GUARANTEED LOAN PROGRAM**

Eligible applicants include lenders who have the legal authority, financial strength and sufficient experience to operate a successful lending program. This includes lenders that are subject to supervision and credit examination by the applicable agency of the United States or a State.

#### **Use of funds:**

*Funds can be used to construct, enlarge, extend or otherwise improve essential community facilities. Guarantee funds can also be used for refinancing the debt of an essential community facility.*

Examples of essential community facilities include:

- » Health care facilities and services, including but not limited to hospitals
- » Fire rescue, and public safety facilities and services
- » Community, public, social, educational, or cultural facilities or services
- » Transportation facilities such as streets, bridges, roads, ports, and airports

- » Certain utility projects when not eligible for Rural Utilities Service financing, gas distribution systems, recycling and transfer centers or stations
- » Telecommunications end-user equipment when related to public safety, medical, or educational telecommunication links when not eligible for Rural Utilities Service financing
- » Water infrastructure facilities such as levees, dams, reservoirs, inland waterways, canals, and irrigation systems
- » Purchase and installation of renewable energy systems for use by an essential community facility (conditions apply)
- » Land acquisition and necessary site preparation including access ways and utility extensions to and throughout an industrial park site
- » Community parks, community activity centers, and similar types of facilities

### **ELECTRIC INFRASTRUCTURE LOAN & LOAN GUARANTEE PROGRAM**

Eligible applicants include most retail or power supply providers serving qualified rural areas, including state and local governmental entities, federally-recognized Tribes, nonprofits including cooperatives and limited dividend or mutual associations, and for-profit businesses.

#### **Use of funds:**

- » Maintenance
- » Upgrades
- » Expansion
- » Replacement of distribution, sub transmission and headquarters (service, warehouse) facilities
- » Energy efficiency
- » Renewable energy systems
- » For additional details, see the Code of Federal Regulations

**\*Applications accepted on a rolling basis**

**\*Loan guarantees up to 100%**

### **RURAL ECONOMIC DEVELOPMENT LOAN & GRANT PROGRAM IN LOUISIANA**

Eligible applicants include current Rural Utilities Service (RUS), electric or telecommunication borrower, any former RUS borrower that has repaid or prepaid an insured, direct or guaranteed loan under the Rural Electrification Act, or any not-for-profit utility that is eligible to receive an insured or direct loan.

- » USDA provides zero-interest loans to local utilities which they, in turn, pass through to local businesses (ultimate recipients) for projects that will create and retain employment in rural areas.
- » Funding can be used to establish Revolving Loan Funds (RLFs)

**\*Application deadlines for quarterly funding competitions are no later than 4:30 p.m. (local time) on:  
First Quarter, September 30; Second Quarter, December 31; Third Quarter, March 31; and Fourth  
Quarter, June 30.**

**\*\$300K Max grant amount**

**\*\$2M Max loan amount**

**RURAL HOUSING SITE LOANS**

Eligible applicants include private or public non-profit organizations, non-profits that have the legal authority to operate a revolving loan fund, non-profits that have the financial, technical and managerial capacity to comply with relevant federal and state laws and regulations, federally-recognized tribes

- » USDA Rural Development offers specific loans to eligible entities to purchase and develop housing sites for low- and moderate-income families.

**TELECOMMUNICATIONS INFRASTRUCTURE LOANS & LOAN GUARANTEES**

Eligible applicants include most entities that provide telecommunications in qualified rural areas including state and local governmental entities, federally recognized tribes, non-profits, including cooperatives, and limited dividend or mutual associations, for-profit businesses.

- » This program provides financing for the construction, maintenance, improvement and expansion of telephone service and broadband in rural areas.

**\*Applications accepted on a rolling basis**

**\*Max up to 80%**

**U.S. Environmental Protection Agency****EPA WATER INFRASTRUCTURE FINANCE AND INNOVATION ACT (WIFIA)**

Eligible applicants include:

- » Local, state, and tribal government entities, partnerships and joint ventures, corporations and trusts, and clean Water and Drinking Water State Revolving Fund (SRF) programs
- » WIFIA program can fund development and implementation activities for eligible projects
- » Development phase activities, including planning, preliminary engineering, design, environmental review, revenue forecasting, and other pre-construction activities
- » Construction, reconstruction, rehabilitation, and replacement activities
- » Acquisition of real property or an interest in real property, environmental mitigation, construction contingencies, and acquisition of equipment
- » Capitalized interest necessary to meet market requirements, reasonably required reserve funds, capital issuance expenses and other carrying costs during construction

**U.S Department of Transportation****RAILROAD REHABILITATION AND IMPROVEMENT FINANCING (RRIF) PROGRAM**

Eligible borrowers include railroads, state and local governments, government-sponsored authorities and corporations, limited option freight shippers that intend to construct a new rail connection, and joint ventures that include at least one of the preceding.

- » Direct loans and loan guarantees to acquire, improve, or rehabilitate intermodal or rail equipment or facilities including track, components of track, bridges, yards, buildings and shops, and including the installation of positive train control systems; develop or establish new intermodal or railroad facilities; and finance transit-oriented development.

## Louisiana Department of Environmental Quality

### BROWNFIELD CLEANUP REVOLVING LOAN FUND

- » Public, private and nonprofit entities are all eligible to apply for LDEQ's Brownfield Cleanup Revolving Loan Fund (BCRLF) which provides low interest loans with flexible terms to support the environmental cleanup of vacant and underutilized properties to get them ready for reuse.
- » LDEQ's BCRLF currently has a 0% interest rate, and nonprofit and government entities are eligible for 30% loan forgiveness. Funding goes to the entity applying for assistance who then hires a qualified environmental contractor to complete cleanup activities. Repayment generally starts six months after the Certificate of Occupancy is issued or two years after the cleanup is completed (whichever is first) to allow time for the project to produce income

## Louisiana Department of Health and Hospitals

### THE DRINKING WATER REVOLVING LOAN FUND PROGRAM (DWRLF)

- » Established to provide low-interest loans and technical assistance to public water systems in the state to assist them in complying with Federal and State drinking water regulations and to ensure that their customers are being provided with safe drinking water in order to protect the public health.
- » **Technical Assistance**  
Some of the monies are designated for technical assistance to small public water systems serving under 10,000 population.

## Louisiana Public Facilities Authority

### LOW INTEREST LOCAL GOVERNMENT BOND BANK PROGRAM

- » The LPFA's Low Interest Local Government Bond Bank Program saves local governments money by providing up to 25% of a financing at a reduced interest rate.

**\*Max up to 25%**

### RURAL DEVELOPMENT LOW INTEREST LOAN PROGRAM

- » The LPFA's Rural Development Low Interest Loan Program helps provide local governments and non-profits with interim financing for capital and infrastructure projects until permanent financing is received from the U.S. Department of Agriculture's (USDA) Rural Development Program.

**\*Max up to 40%**

## Grants

### Delta Regional Authority

#### COMMUNITY INFRASTRUCTURE FUND (CIF)

Investments support projects that address flood control, basic public infrastructure and transportation infrastructure projects.

Eligible applicants include:

- » Counties/parishes, cities, or other political subdivisions of a state, including a special purpose district of a state or local government engaged in economic or community development activities or a consortium of political subdivisions,
- » Public or private nonprofit organizations or associations,
- » Regional development organizations,
- » Economic development organizations,
- » Workforce investment boards,
- » Unions/labor organizations,
- » Community-based organizations,
- » Faith-based organizations,
- » Public Institutions of higher education or a consortium of institutions of higher education,
- » Minority-serving institutions,
- » Trade/technical schools,
- » Historically Black Colleges & Universities, and
- » Basic public infrastructure, including water and wastewater facilities, electric and gas utilities, broadband delivery, and solid waste landfills; transportation infrastructure such as local roadways, bridges, rail, port facilities, airports; flood control

**\*\$500K-\$2M Max award**

### USDA Rural Development

#### EMERGENCY COMMUNITY WATER ASSISTANCE GRANTS

To be eligible, the applicant must be rurally located public bodies, nonprofit organizations, federally recognized tribes

**Use of funds:**

- » Water transmission line grants up to \$150,000 to construct waterline extensions, repair breaks or leaks in existing water distribution lines, and address related maintenance necessary to replenish the water supply
- » Water source grants up to \$1,000,000 are to construct a water source, intake or treatment facility

**\*Applications accepted on a rolling basis**

**\*\$150K max water transmission line grant**

**\*\$1M max water source grant**

### MULTIFAMILY HOUSING RENTAL ASSISTANCE

This program provides payments to owners of USDA-financed Rural Rental Housing or Farm Labor Housing projects on behalf of low-income tenants unable to pay their full rent.

- » Project owners as part of their Rural Rental Housing or Farm Labor Housing new construction financing applications are eligible to apply.

### MUTUAL SELF-HELP HOUSING TECHNICAL ASSISTANCE GRANTS

Provides grants to qualified organizations to help them carry out local self-help housing construction projects. Grant recipients supervise groups of very-low- and low-income individuals and families as they construct their own homes in rural areas. The group members provide most of the construction labor on each other's homes, with technical assistance from the organization overseeing the project.

- » Eligible applicants include government non-profit organizations, federally-recognized tribes, and private non-profit organizations

### SPECIAL EVALUATION ASSISTANCE FOR RURAL COMMUNITIES AND HOUSEHOLDS IN LOUISIANA

This program helps very small, financially distressed rural communities with predevelopment feasibility studies, design and technical assistance on proposed water and waste disposal projects.

- » Most state and local governmental entities, nonprofits, and federally recognized tribes are eligible to apply.

### STRATEGIC ECONOMIC AND COMMUNITY DEVELOPMENT

To be eligible for SECD, a project must be eligible for the covered program, be carried out in a rural area, support a multi-jurisdictional and multi-sectoral strategic community investment plan.

#### **Use of funds:**

- » SECD supports projects that promote and implement strategic community investment plans. Rural Development also can assist by identifying additional resources, convening partners, and helping leverage federal, state, local and private funding.

### WATER & WASTE DISPOSAL LOAN AND GRANT PROGRAM IN LOUISIANA

This program assists qualified applicants who are not otherwise able to obtain commercial credit on reasonable terms. Eligible applicants include most state and local governmental entities, private nonprofits, and federally-recognized tribes.

**Use of funds:**

- » Drinking water sourcing, treatment, storage and distribution
- » Sewer collection, transmission, treatment and disposal
- » Solid waste collection, disposal and closure
- » Storm water collection, transmission and disposal

In some cases, funding may also be available for related activities such as:

- » Legal and engineering fees
- » Land acquisition, water and land rights, permits and equipment
- » Start-up operations and maintenance
- » Interest incurred during construction
- » Purchase of facilities to improve service or prevent loss of service
- » Other costs determined to be necessary for completion of the project
- » See [7 CFR Part 1780.7 and 1780.9](#) for a complete list.

**WASTE & WATER DISPOSAL PREDEVELOPMENT PLANNING GRANT**

Eligible applicants include rural areas and towns with populations of 10,000 or less and federally recognized tribal lands.

- » This program helps eligible low-income communities plan and develop applications for proposed USDA Rural Development water or waste disposal projects.

**\*Applications accepted on a rolling basis**

**\*\$60K Max award**

## U.S. Department of Commerce NOAA Office of Coastal Management

**COASTAL ZONE MANAGEMENT HABITAT PROTECTION AND RESTORATION COMPETITION**

- » Any coastal state or territorial CZM Program that has been approved by NOAA is eligible for funding which can be used for eligible state and territory Coastal Zone Management Programs for coastal habitat restoration; coastal habitat restoration planning, engineering, and design; and coastal land conservation projects.

**\*Application Deadline January 9, 2025**

**\*\$200K-\$6M Max award**

## U.S. Department of Homeland Security-FEMA

**STATE AND LOCAL CYBERSECURITY GRANT PROGRAM**

The State and Local Cybersecurity Grant Program provides funding to eligible entities to address cybersecurity risks and threats to information systems owned or operated by, or on behalf of, state, local, or tribal governments. States, Territories and local governments are eligible to apply. Local governments can participate in the SLCGP as sub recipients to their state.

**\*Application Deadline December 3, 2024**

## U.S. Department of Housing and Urban Development

### COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ENTITLEMENT PROGRAM

Eligible applicants include principal cities of Metropolitan Statistical Areas (MSAs), other metropolitan cities with populations of at least 50,000, qualified urban counties with populations of at least 200,000

#### Use of funds:

- » Acquisition of real property
- » Relocation and demolition
- » Rehabilitation of residential and non-residential structures
- » Construction of public facilities and improvements, such as water and sewer facilities, streets, neighborhood centers, and the conversion of school buildings for eligible purposes
- » Public services, within certain limits
- » Activities relating to energy conservation and renewable energy resources
- » Provision of assistance to profit-motivated businesses to carry out economic development and job creation/retention activities

### SECTION 108 LOAN GUARANTEE PROGRAM

Eligible applicants include the following public entities:

- » States
- » Metropolitan cities and urban counties (i.e., CDBG entitlement recipients)
- » Non-entitlement communities that are assisted in the submission of applications by States that administer the CDBG Program
- » Non-entitlement communities eligible to receive CDBG funds under the HUD-Administered Small Cities CDBG Program
- » The Section 108 Loan Guarantee Program (Section 108) provides Community Development Block Grant (CDBG) recipients with the ability to leverage their annual grant allocation to access low-cost, flexible financing for economic development, housing, public facility, and infrastructure projects.

### THRIVING COMMUNITIES TECHNICAL ASSISTANCE

Eligible applicants include general local government, which include villages, towns, cities, counties, and other small municipalities, as well as tribes.

- » Technical assistance designed to support coordination and integration of transportation and housing in infrastructure planning and implementation. Jurisdictions can leverage infrastructure investments to revitalize communities, ensure equitable access to resources, create economic opportunities for residents and businesses, and improve housing availability, affordability, and quality.

## U.S Department of Transportation

### ACCELERATED INNOVATION DEPLOYMENT (AID) DEMONSTRATION GRANTS

Deploy pilot, innovative practices, or technologies in any phase of a highway transportation project between project planning and delivery to significantly accelerate the adoption of innovative technologies by the surface transportation community.

- » Entities eligible to apply are State departments of transportation (State DOT), Federal Land Management Agencies (FLMA), and tribal governments.

**\*Application Deadline: April 15, 2025**

**\*100K-1M Max award**

### FY24 FEDERAL-STATE PARTNERSHIP FOR INTERCITY PASSENGER RAIL GRANT PROGRAM

Eligible applicants include city or township governments, county governments, and state governments. The purpose of this program is to fund capital projects that reduce the state of good repair backlog, improve performance, or expand or establish new intercity passenger rail service.

**\*Application Deadline: December 16, 2024**

### TRANSPORTATION ALTERNATIVES PROGRAM

- » The Transportation Alternatives (TA) Set-Aside from the Surface Transportation Block Grant (STBG) Program provides funding for a variety of generally smaller-scale transportation projects such as pedestrian and bicycle facilities; construction of turnouts, overlooks, and viewing areas; community improvements such as historic preservation and vegetation management; environmental mitigation related to stormwater and habitat connectivity; recreational trails; safe routes to school projects; and vulnerable road user safety assessments.

## U.S. Economic Development Administration

### PUBLIC WORKS AND ECONOMIC ADJUSTMENT ASSISTANCE PROGRAMS INCLUDING CARES ACT FUNDING

Under this NOFO, EDA solicits applications from applicants in order to provide investments that support construction, non-construction, planning, technical assistance, and revolving loan fund projects under EDA's Public Works program and EAA program.

Eligible applicants include a state, an Indian Tribe, a city or other political subdivision of a state, and an entity whose application is supported by a state or political subdivision of a state and that is:

- » Eligible applicants include state governments
- » Native American tribal governments (Federally recognized)
- » City or township governments
- » Country governments
- » Nonprofits
- » Private institutions of higher education
- » Special district governments
- » Public and State controlled institutions of higher education

## U.S. Environmental Protection Agency

### COMMUNITY CHANGE GRANT PROGRAM

- » The Community Change Grants will fund community-driven projects that address climate challenges and reduce pollution while strengthening communities through thoughtful implementation. This historic level of support will enable communities and their partners to overcome longstanding environmental challenges and implement meaningful solutions to meet community needs now and for generations to come. There will be two tracks of funding under this opportunity. Track I will fund approximately 150 large, transformational community-driven investment grants of \$10 million - \$20 million. Track II will fund approximately 20 meaningful engagement grants of \$1 million - \$3 million. Grants cannot exceed 3-years in duration.

### REGION 6 TARGETED BROWNFIELDS ASSESSMENT
